Lounge and Range Rules

General Rules:

1. Our range is a pistol range. However, during the last hour we are open, we allow AR-15 style rifles with caliber restrictions: 5.56, .223, & .300 Blackout. All rifle ammo used in the range must be bought from GGC. (This is the only way we can ensure no military, armor piercing, or tracing rounds are used.) Pistol Caliber Carbines are able to be shot in the range any time.
2. You must be 21 years or older to be a member. Guests must be 18 years or older to use the range. Family/Children ages 12-17 years are allowed to use the range on "Family Day" – Sunday's from 5-7pm, after they have taken a hands-on safety course. Minors take our Safety Class for free with a paid adult.
3. Vulgar language and obscene jokes and material are not allowed within the club.
4. All members must maintain a clean and presentable appearance while at the club. For example, no muddy boots, dirty clothes, greasy hands/clothing, etc.

5. Giving your membership badge to another person for them to use will result in immediate termination of your membership – no exceptions or refunds.
6. If your badge is lost, it is up to you to report it immediately to the concierge so we can cancel your badge and issue you a new one. There will be a \$25 charge to replace any lost or stolen badges.
7. No alcohol or tobacco products (including “vaping”) are allowed in the club (cigars are allowed ONLY in the Cigar Lounge). Coffee and snacks are allowed in The Gatling Lounge.
8. The Cigar Lounge and its bathroom at Glacier Gun Club is for Summit Members ONLY. Rainier members must use the restroom located in the Liquor Store.

Range Rules:

9. Members may bring multiple guests in during a single visit. However, a single-lane restriction may apply to give priority to other members if space is limited.
10. NO Food or Drinks are allowed within the range at any time. No exceptions.
11. Proper eye and ear protection must be worn prior to walking through the first door of the sally port to the range, and at all times while in the range.
12. Only 2 people are allowed per lane unless otherwise instructed by Glacier Gun Club Staff.
13. No going beyond the firing line at any time (where the black carpet meets the concrete). This includes hockey sticks, brooms, etc. NOTHING may go past the firing line.
14. Cross-lane firing or shooting at anything other than your own target is strictly prohibited. Any person seen firing at lights, baffles, carriers, walls, or any other range property or equipment will be removed from the range, barred from future use of Glacier Gun Club facilities, and reported to the proper authorities for appropriate action. You will be held accountable and may have to pay for any damage you cause by not following these range rules.
15. Your firearm is assigned to a lane; therefore, no passing of firearms from lane to lane is permitted. If you would like to share your firearm with a friend, place the firearm on the bench in its assigned stall and allow your friend to shoot from its designated lane.
16. When you are finished shooting, secure your firearm in a case or holster, clean up around your booth by throwing trash in the receptacle provided and by sweeping brass forward of the firing line. Please inform the Glacier Gun Club staff of any equipment that does not appear to be operating properly.
17. Commands issued by the Glacier Gun Club Staff must be followed immediately. Glacier Gun Club Staff are authorized to remove any shooter whose behavior is detrimental to the safe operations of the of the range.
18. When the command “CEASE FIRE” is given (OR when the range lights go off and on three times), stop shooting IMMEDIATELY, remove your finger from the trigger, keep the gun pointed downrange, and wait for further instructions from Glacier Gun Club Staff.
19. Firearms will only be uncased or removed from the holster within the shooting stalls/lanes. Load and unload all firearms in your assigned lane on your bench. No uncased firearms are permitted outside of the shooting stall.
20. No holster or quick draw shooting allowed on the range unless you have been signed off by a Glacier Gun Club Firearms Instructor.

21. Expectant mothers are not permitted on the range at any time without prior written physician consent.
22. No inexperienced shooters are allowed on the range without prior instruction, coaching, and approval of a Staff member. Glacier Gun Club Staff has final say on this rule
23. Only Glacier Gun Club ammo may be used in our rental firearms. A \$50.00 fine will be issued to those in violation of this rule.
24. No one is allowed inside the range area unless they have read these range rules, signed our liability waiver, and have been assigned a lane by Glacier Gun Club Staff.
25. No drinking alcohol 8 hours prior to shooting at Glacier Gun Club.

Parking Rules:

26. No parking in the front row of T Brothers Liquor Lodge at any time. These spots are for the Liquor Lodge patrons only.

Cancellation Policy

I, _____, understand that to cancel my membership and avoid future membership dues, I must return my membership badge and locker key (if applicable) to a staff member more than 24 hours in advance of my monthly billing date.

Non Payment Policy

___ Initials: I will be charged a fee of \$25 for my badge deactivation and replacement.

___ Initials: My locker will be punched, cleaned out and rekeyed, for which I will be charged a fee of \$50.

___ Initials: I will have 7 calendar days upon my locker being cleared out to collect any personal possessions. After 7 days, Glacier Gun Club has the right to dispose of the contents.

RANGE USER AGREEMENT, LIABILITY RELEASE, AND ACKNOWLEDGEMENT OF RISK

For All Participants and All Observers in consideration of the services of GLACIER GUN CLUB, their agents, owners, officers, volunteers, participants, employees, and all other persons or entities acting in any capacity on their behalf (hereinafter collectively referred to as " GGC "), I hereby agree to release and discharge GGC, on behalf of myself, my children, my parents, my heirs, assigns, personal representative and estate as follows:

I, _____, acknowledge that target practice at a shooting range entails known and unanticipated risks which could result in serious physical or emotional injury, paralysis, death, dismemberment, or damage to myself, to property, or to other persons. The risks include, but are not limited to:

1. Participation may result in the undersigned or other persons being shot by a firearm; suffering hearing loss; eye injury or loss; inhalation or contact with airborne contaminants and or flying debris, slipping or falling on uneven or loose terrain, and hazards associated with an indoor firing range. Furthermore, GGC employees have difficult jobs to perform. They seek safety, but they are not infallible. They might be unaware of a participant's fitness or abilities. They may give inadequate warnings or instructions, and the equipment being used might malfunction.
2. I further certify that I have no medical, mental or physical conditions which could interfere with my safety in this activity, or if such conditions exist, I have made an informed judgment that they are minor, and I am willing to assume the risks that my conditions create, directly or indirectly, and bear the costs and responsibilities for those conditions.
3. I expressly agree and promise to accept and assume all of the risks existing in this activity. My participation in this activity is purely voluntary, and I elect to participate in spite of the risks.
4. I hereby voluntarily release, forever discharge, and agree to indemnify and hold harmless GGC from any and all claims, demands, or causes of action, which are in any way connected with my participation in this activity or my use of GGC's equipment or facilities, including any such Claims which alleged negligent acts or omissions of GGC.
5. Should GGC or anyone acting on their behalf, be required to incur attorney's fees and costs to enforce this agreement, I agree to indemnify and hold them harmless for all such fees and costs.
6. I certify that I have adequate insurance to cover any injury or damage I may cause or suffer while participating, or else I agree to bear the costs of such injury or damage to myself or others.
7. The parties hereby waive the right to a trial by jury in any action or proceeding related to the subject matter of this agreement. If a dispute arises out of or relates to this agreement, any liability release, assumption of liability or assumption of risk, or any injury or claim by the participant against GGC, the parties agree by signing this document:

I acknowledge that if anyone is hurt or property is damaged during my participation in this activity, I may be found by a court of law to have waived my right to maintain a lawsuit against GLACIER GUN CLUB on the basis of any claim from which I have released them herein. I have had sufficient opportunity to read this entire document. I have read and understood it, and I agree to be bound by its terms.

Lead Exposure Liability Waiver

- I will promptly report any safety concerns or incidents to the range staff.
- I release and discharge Glacier Gun Club, its owners, employees, agents, and representatives from any and all claims, liabilities, demands, actions, and causes of action whatsoever, arising out of or related to any loss, damage, or injury, including death, that may be sustained by me, or any of my property, while participating in activities at Glacier Gun Club.

I understand that this waiver is a legal document and I voluntarily sign it of my own free will. I acknowledge that I have had the opportunity to seek independent legal advice before signing this waiver.
